When to Apply in QAP	2016, 2017, 2018, and 2019, or until grant funds are exhausted	2016, 2017, and 2018
Applying outside of QAP	Developers with existing units may apply anytime until grant funds are exhausted	Developers with existing units may not apply
Unit Integration	No more than 25% of units in a development may be set aside for persons with a disability; those units cannot be concentrated	No more than 25% of units in a development may be set aside for persons with a disability; those units cannot be concentrated
Targeted Areas	Approximately 60% urban, 40% rural	Areas with a high number of HOME choice transitions; See HOME Choice Transitions by County Map
Target Population	HOME Choice (in facilities), HOME Choice (in communities), and other persons receiving Medicaid	HOME Choice (in facilities), HOME Choice (in communities), or individuals in other programs approved by ODM
Eligibility Restriction	At least 18 and no more than 61 years of age at entry	Head of household at least 18 years of age

Tenant Services/Supports	Eligible; types of services/supports based on Medicaid coverage	Eligible; types of services/supports based on Medicaid coverage
Unit Size	One-bedroom units receive priority: two-bedroom units may be considered for special circumstances.	One and two-bedroom units; priority will be for one bedroom units
Section 504 Requirements	Required for the building, but not 811 units	Required for the building and ODMSD units
Fixed or Floating	Floating	Can be either, but units must conform to Section 504 requirements
Tenant Application Process	Individuals are pre-screened by an online database, SocialServe; State makes referrals to eligible properties	Individuals are pre-screened by online database (SocialServe); State makes referrals to eligible properties
