TO: All Registered Referral Agents for the Ohio 811 Program

RE: 811 Waitlist Management

Thank you for acting as a Referral Agent for the Ohio 811 Program! We appreciate your efforts in making this important demonstration program successful. The information in this memo is intended to expedite the referral of eligible individuals from the program waitlist to participating properties, and to identify those whose contact information is out of date. We are also working with property managers to decrease delays once individuals are actually referred to properties.

The process outlined below will improve the efficiency of 811 referrals. Please review these steps and begin working on them now. A webinar will be offered on May 19, 2021 at 10:00 a.m. for those who have questions. We ask that you complete your review of all those on your waitlist on or before June 11, 2021. Email the waitlist manager at 811Program@ohiohome.org when you have completed the review.

Updating the Waitlist

Follow these steps to remove those who will no longer participate in the 811 Program, assess the readiness to move of those who wish to participate, and remove those who you can no longer contact.

1. Starting from the oldest entry, identify those individuals who should be removed from Socialserve. Look for those whose situations have changed and who no longer need or require an 811 unit, including those who have obtained stable and affordable housing, those who are no longer interested in or eligible for the program, or those who have passed away. If you are acting as the sole Referral Agent for your agency and you do not have personal knowledge of each candidate, making this determination may require you to have a conversation with a colleague, the individual, or the individual's family or representative.
2. Next, remove those individuals from Socialserve. Navigate within Socialserve to the Applicant Status section (see attached screenshot for instructions). You will be presented with four options for removing individuals from the waitlist: Deceased, Withdrawn by Applicant, Duplicate or Other. If the reason for removal is one of the first three, select the appropriate option, which will permanently remove that person from the waitlist. If the reason is "Other", do not select Removed: Other, but instead notify the Waitlist Manager by sending an email to 811Program@ohiohome.org with the individual's name and the reason for removal. Upon receiving notification that you have completed the review, the Waitlist Manager will permanently remove the person or ask you for more information about their situation.
3. Review and assess those remaining for readiness to move within 90 days. Familiarize yourself with the property timelines in counties in which you will be referring potential tenants. If you are in a county that has properties coming online in 6-9 months, you can use a longer timeline to evaluate readiness. A current list of properties and their upcoming availability is attached to this notice to help you make those determinations. Use the comment box in Socialserve to make a note about the individual's readiness to move. Only make comments in the box for those individuals who will not be ready to move within 90 days or within the

timeframe that applies for your county. Be specific, for example, if you make a comment be sure to include dates (e.g., Individual A is in short-term stabilization, he will be ready to move on July 1, 2021 or thereafter). *This will not change their place on the waitlist, nor will it cause the individual to be removed from the waitlist.*

4. Confirm and update information in Socialserve for each individual who will remain on the waitlist. If you are unable to contact someone because contact information is no longer valid, and no other information is available, notify the Waitlist Manager by sending an email to 811Program@ohiohome.org with the individual's name and report that you are unable to contact the person with the current information. Upon receiving notification that you have completed the review, the Waitlist Manager will permanently remove the person or ask you for more information about their situation. If you believe that the inability to contact someone is temporary, leave them on the waitlist and continue to reach out to them periodically as you regularly manage your waitlist.

Indicating interest before the referral is made

A recent update to Socialserve allows Referral Agents to respond to an individual's interest or lack of interest. The Waitlist Manager will notify the Referral Agent of an available unit before the official referral to measure interest in a particular property. When you receive this notification, you can go into Socialserve to indicate whether the individual is interested in a property. Referral Agents must respond to these notices within 3 days, but they will still have 10 days to start the application process once a referral is issued, unless a reasonable accommodation for more time is requested. We will address this process in the upcoming webinar, which will be recorded and made available for those who cannot attend. This update to Socialserve should improve efficiencies in the program, as it will allow us to move on to the next individual on the waitlist in the event someone indicates they are not interested in the referral.

Ongoing Management of the Waitlist

Ongoing management of the information in Socialserve is necessary to keep the waitlist current and expedite the referral process. Continuously assess each individual's readiness to move as it may change. Additionally, new apartments will continue to come online, so you will most likely need to adjust based on timeline restructuring. We suggest scheduling a regularly monthly check-in.

If an individual has certain requirements or preferences for property location or specific amenities, use the comment box at the end of the Housing section to express that need or preference. Please note that an individual will receive all referrals for which they are eligible based on their county preference(s), and that continued declining of referrals may result in removal from the waitlist.

Respond to any notices from Socialserve regarding recertifications that are past due. The system will flag those who have not been recertified, and will not allow them to be referred to a property until recertification is completed.

Thank you for your time and attention to these items. We hope that these steps will help to move people into appropriate housing as efficiently as possible.
