



Below is the list of current Ohio Housing Finance Agency forms that have been added or updated to reflect the Housing Opportunity Through Modernization Act of 2016 (HOTMA) rule. Forms highlighted in **orange** reflect new forms or those with HOTMA updates.

It is important to remember that use of the HOTMA forms (i.e. those highlighted in orange) is **optional until** January 1, 2025. On and after this date, these forms become **mandatory** for all new move-ins and recertifications. If an OHFA form is not listed below, then no change occurred to the form.
